

I recognize it may be carrying coals to New Castle, that a 1 man who has spent many years as an officer in the Central 2 Intelligence Agency has a conditioned reluctance to disclose 3 methods notwithstanding the acknowledged entitlement of this 4 committee to receive such information if the committee deems 5 the information pertinent but I raise this point only by way 6 of appealing to the committee as we may from time to time, if 7 considered necessary, to carefully weigh the pertinence or 3 relevance or indispensability of names of persons who may have \$ risked life or limb or liberty or careers in the service of 10 the United States. If that information is deemed relevant, 11 there is no question that it will be provided if we are called 12 but there may be cases where the committee feels that although 13 it would be entitled to the information it can do without it 14 and in such cases we would request that the committee forego 15 the identification of persons. 16

That includes the identity of the witness himself. It would be tragic or could be tragic if the fact were disclosed to the press, for example, that he appeared before this committee in the capacity of a witness.

Finally, only by way of underscoring what I have said and notwithstanding Acting Director Carlucci's letter to the committee, this officer, like others in his category, feels a personal fiduciary responsibility toward persons whom he induced to work in a clandestine capacity for the United States
