MY IMMEDIATE RIGHT AND I WAS THE BECOND PERSON FROM THE DOOR ON THE NOATH SIDE OF THE HELLWAY WHICH LEADS TO THE JAIL OFFICE DOOR. I DO NOT KNOW WHO WAS ON MY LEFT. AT APPROXIMATELY 11:25AM CAPTAIN FRITZ CAME OUT THE JAIL OFFICE DOOR AND ASKED WAS EVERYTHING ALL RIGHT AND I ANSWERED "YES SIR". I DO NOT KNOW IF HE WAS SPEAKING DIRECTRY TO ME. TWO HOMOCIDE DETECTIVES WERE HOLDING ONTO THE PRISONER ESCORTING KIM AND IT RECOGNIZED DETECTIVE LAVELLE ON THE PRISONER'S LEFT.
